18 Wolrige Mahon, Ltd., the foreign representative (the "Canadian Trustee"), seeking entry
19 of an order enforcing the Court's February 21, 2007 Stipulated Order re Conduct of 2004
20 Examination (the "Order") and compelling discovery ("Motion"); notice was properly
21 given as required by Local Bankruptcy Rule 9013-1 and the Court having considered the
22 Declarations of Bruce W. Leaverton and Gregory R. Fox, the Debtor's response and his
23 assertion of the Fifth Amendment, the reply of the Canadian Trustee, and the records and
24 files herein; and having heard argument of counsel and being fully advised in the premises,
25 NOW, THEREFORE, IT IS HEREBY

26 ORDERED that the Canadian Trustee's Motion is GRANTED; and it is further

1 ORDERED that the Debtor is compelled to provide the Canadian Trustee with
2 full and complete substantive answers and responses to the written questions attached to
3 the Order and to produce all of the documents requested in the subpoena attached to the
4 Order, no later than June 29, 2007. It is further

5 ORDERED that this order is without prejudice to the Canadian Trustee's right to
6 move for future examinations or discovery.
